Subject: Follow up on in-patient vaccination

What's new

First doses of the COVID-19 vaccines is scheduled to be given to in-patients who are 60 years or older according to this timeline:

- General Site Friday, April 09
- Juravinski Site Monday, April 12
- Satellite Health Facility Tuesday, April 13
- West Lincoln Friday, April 09

What HHS leaders and physicians need to do

Clinical leaders are asked to support this effort by getting orders and getting consent from patients (or authorized decision-maker).

Eligible patients can be vaccinated via two processes:

- Identification by the inpatient teams and activation of the HHS Medical Directive
- The medical directive can be initiated by any Regulated Health Professional on the inpatient unit.
 - NOTE: Sue Ann McAlpine and Brenda St. Amant will be meeting with the inpatient teams to review the related processes. Inpatient teams will be required to ensure that signed consent forms are completed prior to the day of scheduled vaccinations.
- For any patient, for whom there is the need for review by the MRP (Medical complexities, concerns re: the patients eligibility), the inpatient teams will reach out to the MRP to complete consent and a written order for the vaccine.

NOTE: the electronic order sets will soon be available in the Order Set Library. This PDF can be used in the meantime.



Vaccination for patients with active or immediately after COVID infection

The regional Subject Matter Expert (SME) group recommends **not** to vaccinate patients with current (active) COVID infection

- At a minimum, patients should be considered resolved prior to getting the vaccine.
- Unless there is a pressing need to get them vaccinated after a recent infection (e.g. as a condition for admission to a congregate care/LTC facility), the SME group does not recommend vaccination prior to the three months after a confirmed active infection, in accordance with the recommendation by the National Advisory Committee on Immunization.
